# OSHA ENFORCEMENT

- State or Federal agency
- Conducts inspections & accident investigations
- Issues citations and levies fines

# BREWERY REPRESENTATIVES

- H&S regulations seem complicated
- Compliance is resource intensive
- Generally fearful of an OSHA visit

# OSHA CONSULTATION

- State or Federal agency
- Conducts non-punitive, confidential H&S audits
- Helps employers identify hazards
- Provides compliance guidance and resources
